President's Message

In this issue we highlight our genealogist's report. Transferring all our data into digital records takes a lot of work, and after reading her article, I think everyone will agree Rita G. Eddy is up to the task!

Genealogy, DNA, and 23 & Me

As a direct descendant of John Eddy of Woodbridge, NJ (JOW) I have tried for 40 years to identify where in Scotland JOW was born and where his family originated. But I have come up empty-handed repeatedly. I have never seen any original source data to locate his birth. (I have seen online suggestions that he was born in various places in Scotland – but I've never seen data to support these claims.)

As JOW's 9th great-grandson, he and I share the same Y chromosome, but because of recombination of chromosomes and being 9 generations apart, it's unlikely we share any autosomal (non-sex) chromosomal material. The Y chromosome is different because it doesn't undergo a lot of recombination, DNA results from 23 & Me might be able to show it localizes to a certain portion of Scotland.

Historical data about the Gordon Clan gives us our only clue: Scottish historians have suggested that Scottish Eddy's are considered septs of the Gordons. This means that they lived and worked in the region of Scotland that the Gordons controlled. The Gordons, since the 1200s, have lived in the northeastern Scottish area of Aberdeenshire, near Aberdeen.

So, that brings us to today and the DNA clue.

My family, including my brother and my son, had the 23 & Me genetic tests completed, and the algorithms provided clues to regions of the world where our DNA may have originated. The most recent algorithm suggested my Scottish DNA comes from Aberdeenshire. We now have

what might be considered epidemiological DNA data that is consistent with the historical data of the Gordons.

To travel nine generations back to a poor country to get written records is all but impossible. It may turn out that DNA analysis is the only way forward in a lot of circumstances to localize where ancestors are from.

I'm interested if anyone has DNA data they'd like to share regarding your Eddy/Eddey/Eddye ancestry?

Dear Cousins,

Thanks to each of you that have taken up the request to provide your family stories and remembrances of loved ones in your family lines. Only by sharing memories of family members, traditions and talents now, may the recollection be later shared and enjoyed by others.

Now let's take a next step. How about sharing a bit about you? What would you include in your profile to add a glimpse of personal knowledge to your future descendants?

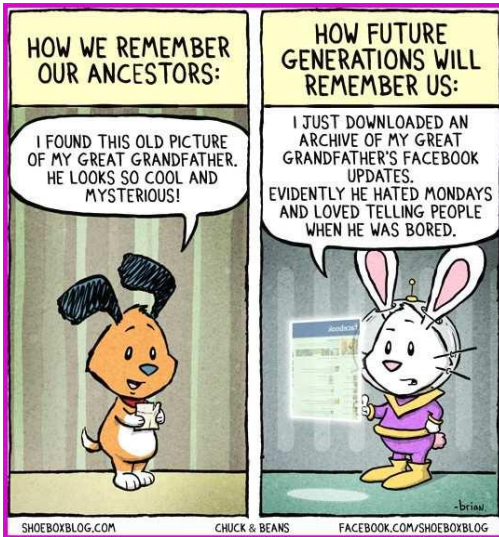
What career path did you take? Did you serve in the military? What are you proud of accomplishing, awards received? Have you traveled? Do you have

a funny story? Are you now, or were you a volunteer? What are your interests, talents, gifts? Do you paint, quilt, knit, sew or crochet, love antiques, classic cars? What hobbies, collections or crafts do you enjoy; stamp or coin collecting, bird watching. Are you an avid reader, author, play an instrument, love to sing? Do you visit museums, attend stage performances. I know this may be tough. Something like "tooting your own horn, being modest, not someone in the

limelight". You have the ability to provide what will be read by future generations, family historians/researchers; and, personalize, improve and strengthen the EFA record.

To those of us with grandchildren, and blessed to spend time regularly with them:

Share your family stories and remembrances of loved ones with them. Take out a photo album when babysitting a grandchild (epics if you must), point out individuals in pictures and share your recollection or story about individuals shown (write names on pics if not already there). Perhaps make



a game of it by drawing a picture with them to tie the story, the photo, and creating their place in the story.

Share with them what the community you grew up in was like. What community activities were there? Did you sled down a favorite hill, fish or swim in a local pond, attend dances, what kind of music did you listen to? Did the family share the holidays, reunions, traditions? Having completed the big push to resolve unconnected material, over the past two months, my focus has been researching and expanding the holdings of the lines of William's pioneering children; Abigail Benjamin, Anna Wines (Wynes), and John through the seventh generation. Currently I am working the sixth generation of Samuel's line. This project started at the second generation, researching for information on children with no additional entry, as well as expanding the data held on those having profiles. It has also provided verification of already held data by source material.

I have enjoyed every moment spent on behalf of the EFA. Thank you for the confidence in me. I continue to be honored at being selected for the role, and more grateful today than last year when offered the position. Thank you, one and all for a wonderful year!

A Treasure Trove of Data!

It has been a very productive 14 months since accepting the role of the EFA's genealogist. It's amazing the conversations I've enjoyed with many members, and non-members, over recent months. Submissions from both members and non-members provided further expansion of EFA holdings, some corrections, and a few connections. Keep them coming! I enjoy hearing from you and watching the lines grow! Your additions are greatly appreciated and vital to the success of our organization.

I have filled many requests for possible information, and it was rewarding to hear the surprise and excitement when you received and read profiles about our common ancestors. In return, many of you provided additional material expanding knowledge of the lines even further. Thank you to all.

To our new members, welcome, and thank you for your generous sharing of family data. Further feedback and suggestions as to how we may better serve the EFA are most appreciated.

Over these months, I have sent two to three letters of introduction each month to state and local genealogical and historical societies to introduce the EFA to their membership. The Eddys have settled far and wide! One responded advising they were planning to publish the information. One returned undeliverable. Have 24 states done, the remainder this year; then retrack and communicate with additional groups in each state.

Now to report on the progress of researching and connecting the unconnected holdings.

There was a total of 569 pages of unconnected, latecomer, appendix, addenda, and short items published in the six books. Surprisingly, there were few duplicate items. All these items have been worked, resulting in most of the submitted material, along with additional new information found during research having been incorporated into the organized lines. Often the initial item was only one or two lines, but research resulted in adding more data to it and several additional new profiles. All successful connections have been formatted in the profile style of the books and passed along to Lin for incorporation into the publication record. About 650 pages of connected material was added to the EFA lines. The majority of items connected to William's line. A substantial number of connections were also made to the John of Taunton and John of Woodbridge lines. Input to the tree(s) is the next step and will be a major task!

Very little has been received on the family lines of Abigail Eddy (Benjamin) and Anna Eddy (Wines or Wynes), the sisters of John and

Samuel who arrived in the same time period and settled in the Boston Bay Colony. I encourage descendants of these lines to provide information to expand the record. A larger amount of information on John's lines has been received, but far less than we should expect. None of the unconnected items worked were tied to the daughters' lines, and only six resulted in a connection to John's line. I'd love to hear from descendants of these lines. There is so much potential to make the EFA bigger and better; together, we CAN make it happen!

There are 97 family groups, some containing multiple pages of information, that resulted in walls which require more intensive research. Kelly will be concentrating her efforts revisiting each of these to discover the connection and incorporate into the designated line. In a further attempt to connect these profiles to their line, a few will be included in each bulletin. Sherri may post them on the social media site(s) in the hope of receiving feedback which may provide a lead or the connection and expand the record.

Additionally, dozens of individual files have been set up of material submitted on individuals of foreign birth, or with foreign born parents, NOT associated with the three currently established lines. Those of you owning the books will find these profiles in the unconnected material as "William Eddy of Ashford England, David Eddy of Rosmergy, England and, Australia, Ireland and Scotland lines" to name a few. Further work organizing and formatting this material will result in the establishment of the additional miscellaneous lines of The Eddy Family in America. Once set up and publicly available, we should expect to see these lines flourish.

The remaining unconnected items (many with new information found when researching) that do not fit into the groups described above have been set up in a new unconnected material log of 115 pages. This log will enable quicker access to these items for occasional further research. These items may be included on the new website for visitors to review with the hope of obtaining additional information and potentially resolving these unconnected lines.

With this work accomplished, ongoing though less intensive attention should be a continuing task.



Sherri, although already contributing in a major way through all her creative work on the bulletin and social media sites, has accepted responsibility for the set up and input of the John of Taunton (“JOT”) tree. This is a major commitment of time and effort. The JOT holdings consist of 326 pages of data for input and continues to expand. Sherri’s line is the JOT line, adding to her passion to see the endeavor accomplished. Sherri is employed fulltime, provides the EFA a dynamic, professional, thoughtful presence through her work on the bulletin and social media sites, finds time to take photos for us, and other special assignments. So happy she is back in action for the EFA!

The John of Woodbridge (“JOW”) tree has been set up and the first four generations have been input. The JOW holdings contain 315 pages of data to be input. This line requires additional research and work to define lines and confirm placements of individuals. I will continue to do small amounts of input to the tree to continue to expand it.

Input of all the newly connected material to the William of Cranbrook tree is also an action item, and it will be a time intensive task! There are currently almost 84,000 individuals in the William “Ancestry” tree. Input of new persons connected and updates to records already established await action.

A fourth tree for the holdings on Joseph, Pioneer of Michigan is a future “to do” item. His line appears to be a second line originating from Scotland but not tied to or identified with the three listed above.

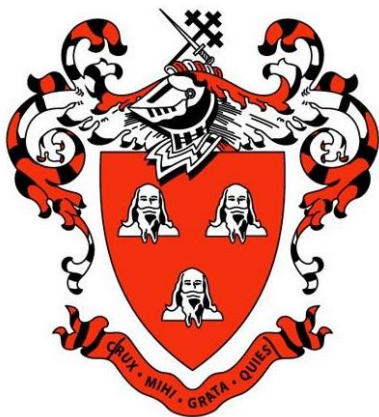
Kathleen Cowan joined the Genealogy Committee last March. Her interest and research in genealogy goes back many years. Kathleen has been assisting researching some of the walls contained in the unconnected material. Presently, she is researching a William line which upon receiving material submitted by a descendant presented a discrepancy in the connection originally set out in the 1930 book. I have confidence in her tenacity and application of all her skills and resources to attempt to resolve and appropriately assign the line to the correct lineage. Many thanks for continuing to push forward and much success in these tough tasks.

Kelly Nawrocki joined the Genealogy Committee last August and has successfully researched and found the connection for several dozen of our broken twigs and branches. Kelly’s line is the John of Woodbridge line and she is attempting to break through a wall at the John Henry and Jensey Sprout family. Anyone have a connection to this line and possibly information they are willing to share and compare? Kelly has an active family, works (formerly taught school), and is pursuing certification as a

genealogist. I am so glad she found us, and grateful for her active participation!

Beverly Eddy has rejoined the Genealogy Committee. Previously, Beverly conducted research within the William tree and has directly input data to the EFA tree, in addition to her ongoing private research and maintenance of her personal tree. Beverly is in the line of William, her husband is in the line of Joseph, Pioneer of Michigan. Currently she is working her personal lines into the profile format used by the EFA publication committee for submittal and inclusion in that record. Many thanks to her for all past efforts and I look forward to her continuing, meticulous research and contributions.

I was born and raised in Massachusetts to first- and second-generation Americans. My family was deeply interested in the history of the area and exposed me to many of the historical sites throughout New England. As a child I spent hours at the local library and loved checking out books, further adding to my interest in history. Can you imagine my delight when, upon moving to Colorado, marrying into the Eddy family and getting hooked on genealogy, I found the connection to the New England roots!! So much of the history I had loved came to life! When visiting Massachusetts with my born and raised “landlocked” Eddy spouse, it was fun taking him to many of the sites, finding the Eddy connections, and yes, visiting the Homestead. The family had no idea their roots were so long grounded in America, having thought their ancestor arrived in the mid-1800s.



I was very excited when I came upon the Eddy Family Association website and quickly signed up to work on the Publication Committee. A lot has been accomplished merging the connected material contained in those six publications. Lin has been tirelessly committed, and I am grateful for the opportunity to participate. Upon getting hooked on genealogy, I completed research on all four of my grandparents' lines, my husband's four grandparents' lines, the lines of my children's spouses and lines of interest to family and friends. My work background was analytical, detail-oriented, working with highly confidential legal information, requiring strict

adherence to law, rules, regulations, and source verification. I had no idea it was preparing me for the role with the EFA!

With 14 years passed since the last publication, members may not know what information on their line is held, or missing, in the EFA record. I encourage interested members to contact me regarding their line. Provide me with (known or guesstimate) your grandfather/grandmother generation, EFA ID #, or lineage, and/or names, dates and locations of birth, death, marriage. With this information, I will perform a search of the EFA holdings, produce a report on the generation before, the information of record for the generation provided, and the following generation. A comparison could be made, and data shared, to fill in missing information or correct as necessary, creating a more complete, accurate record. In addition to sharing statistical data, please remember to include knowledge of your loved one's schooling, occupation, talents, accomplishments, and memories or stories which honor them and provide their future descendants a glimpse of the character and personality of their ancestor. All of us have a favorite aunt, uncle, cousin, accomplished relative; share what made them "special."

The EFA was contacted by a new homeowner of a historic Eddy property regarding how they could respectfully remove a gravestone propped against a tree. The Swansea Historical Society was contacted, and working with the Historical Society of the area where the stone was located, commenced verifying records and coordination of final actions. Initial findings indicated the actual grave to be located at a nearby cemetery. Grateful thanks to all.

Additional thanks to Cheryl at the Swansea Historical Society for the package of document copies. What a pleasant surprise the day I checked the PO Box and found that treasure! Cousins visiting, or living in the area, should definitely drop by and say hello.

Family Submissions

In this section of the Bulletin, we will include contributions of family stories and articles submitted to the EFA by you, our valuable members. This submission is from our EFA President, Gary Eddey.

CARNES EDDEY AND ALFRED EDDY Brothers Who Spelled Their Surname Differently

In my last president's message, I discussed the dilemma genealogists encounter in the John of Woodbridge, New Jersey (JOW) line: were they English or Scottish? I present the case of two brothers who spelled the last name differently; one thought he was from England, and the other knew he was from Scotland.

Both were descendants of James Eddey. James was the first literate Eddey born to John of Woodbridge, and he spelled his surname EDDEY. James' middle son William moved to Staten Island and married a woman of French Huguenot descent; William's son Andrew married Catherine Poillon, also of Huguenot descent.

Carnes and Alfred were born and raised in the southwest corner of Staten Island on a 22-acre farm in the town of Woodrow. The farm, clearly marked on the Beers' Atlas of the day, was handed down to their father Andrew from his father William Eddey. They all spelled their surname with an extra e.

According to William Simonson Eddy, Catherine was a "religious person who mandated strict observance of the Sabbath," which essentially means the boys never missed a Sunday church service at the Woodrow Methodist Episcopal Church.

Fortunately for them, the church sat diagonally across the road from their home. The homestead and small farm have since been replaced by characteristic Staten Island townhouses; however, the wooden church with columns still stands, as does the poorly maintained graveyard that surrounds it.

Both brothers started their careers as ships' carpenters, but it's not clear what they did in the yards as their careers advanced. The census and other records mention that Carnes was a shipwright. His death notice/obituary in the New York Times stated that he worked closely with John Ericsson, the architect of the Monitor, which was the first of the Monitor class ship for the Civil War.

It is doubtful either brother got rich as ship carpenters. Through evidence found in census records and other historical data, shipbuilding work generally paid poorly throughout the century, with the inflation of the post-Civil War period eroding prior wage gains. An average salary of a shipwright might be \$2.00 per hour, with or without inflation. The work days were long – ten hours the norm.

However romantic it may seem, the work of shipyards was dangerous and hard. And, there was no job security. Carnes moved to Marble Hill at the tip of Manhattan after it became an Island – when the Harlem Straight connected the Harlem River to the Hudson River. It is thought that Alfred moved to Morris County, New Jersey to farm. And they both appeared to have small summer homes in western Morris County, New Jersey.

When Carnes and Alfred stopped working in the shipyards, it was not the money they earned from being shipwrights that bought them land in New Jersey. Rather, it appears to have been an inheritance from their mother's family. Of interest, the son of Carnes' oldest daughter Catherine became a Congressman and worked alongside Fiorello LaGuardia before he was elected to the first of four terms as Mayor of New York City.

The brothers who spelled their names differently: Why? It's simple. Alfred's son was the genealogist of the JOW line who was the subject of my previous column and believed he was English. Carnes' youngest son, George W. Eddey, became the Weather Bureau chief on Block Island, Rhode Island, and is the direct ancestor of the writer of this short article. Carnes knew he was Scottish.
